- 1. Owner or owner's representative may determine who may or may not be buried in his/her property.
- 2. Cemetery property deeds are non-transferable. If owner wishes to sell his/her property, the City may buy it back at the original purchase price.
- 3. Purchase price includes the perpetual care of the property at the City's expense. The City will assume responsibility for care of the property and any monument or marker placed on the grave **prior to May 27, 1993**. See Subsection 7 below.
- 4. The City assumes no responsibility for damage to coping, fences, or plant materials installed without the permission of the City.
- 5. The City requires a concrete vault for all burials with the exception of cremated remains.
- 6. Stacked burials will be allowed only on approval of the Cemetery Sexton.
- 7. Grave markers flush with the ground are recommended because of related maintenance costs. Responsible parties requesting monument markers will pay an additional one-time fee and are required to sign a hold harmless agreement below releasing the City from any liability due to damage resulting from weather, age, or maintenance activities.

I hereby waive, release and discharge Park City Municipal Corporation from any and all claims, actions and demands arising out of or in connection with any damage to said statuary/monument property at Park City Cemetery.

I hereby release Park City Municipal Corporation, its officers, employees, agents and servants from any liability, and shall defend, indemnify and hold harmless, Park City Municipal Corporation, its officers, employees, agents and servants from any liability arising from activities associated with the maintenance of the Park City Cemetery and damage to said personal statuary/monument.

I certify that I have read the above authorization and release and I hereby state that I understand the contents, and that I know that in signing it I am signing away any right of claim for any damages sustained to my personal statuary/monument property at Park City Cemetery. I further declare that I signed this release of my own free will.
