

## Library RFP Questions as of 2/09/15

Artist Inquiry -

Could you explain a little more the dimensions of the wall and placement of "obstacles"? Could you walk me through how the wall looks upon entering the very first door? This is how I imagine it...you enter the first door, there is a 14' length of wall then another door. Then \_\_\_\_\_ feet before the first metal support column, then \_\_\_\_\_ feet until the next support column and so on. I'm trying to estimate installation costs.

My second question is will there be any kind of spotlighting to illuminate the art that is provided or will I have to install all of that myself?

I am attaching an image with additional measurements that may be helpful to you.










