PROJECT DESCRIPTION: Park City is excited to launch the Lower Park Avenue Design Studio to develop final concept plans for city-owned property in the Lower Park Avenue Redevelopment Area. This is an innovative approach to bring great minds together to inform a feasible development program for properties owned by Park City Municipal Corporation and/or Park City Redevelopment Authority

The intent of the LOWER PARK AVENUE Design Studio is to provide a framework of the neighborhood that meets the long term vision of the community. The Lower Park Avenue Neighborhood is currently not utilized to its fullest potential. It is a neighborhood full of history with inspiring views of the mountain and acts as a hub that brings community members together. The neighborhood includes a variety of public, private, residential, and resort uses that have the possibility of being woven together. The pockets of Park City owned land provides an opportunity to increase housing in the community and possibly at the same time, create more community focused areas that connect historic Main Street to the Bonanza Drive area.

Neighborhood Components include:

- City Park including the historic Miners Hospital
- Park City Mountain Resort (owned by Vail Resorts)
- Redeveloped Library Center (under Construction)
- Residential Neighborhood

Up to 15 professionals representing a diverse range of professions including design, planning, development and affordable housing will be invited to participate. Park City will provide each finalist with a \$1,500 stipend to cover travel and other expenses. Hotel accommodations as needed and most meals will be provided by Park City Municipal Corporation as the hosts of the Design Studio.
