INFORMATION FOR COMPLETING FOR HIRE VEHICLE APPLICATION FORM

For hire Vehicle licenses are required for anyone with the intent to offer a Taxi, Shuttle and/or a Limo service (in the Park City Limits), in which they are making revenue. Each vehicle is required to have an up to date city for hire sticker on their vehicle. All for hire vehicle licenses are required to be renewed each year by December 31, even if you are exempt from paying a business license fee.

The following is required of all new applicants and renewals:

- All fees must be paid in full
- An inspection form certifying the taxicab or shuttle has passed all requirements established in the Park City Vehicle Inspection Checklist. A current Airport Inspection form, also known as an "AVI Inspection" will take the place of the Park City inspection form; this is required for any vehicle picking up or dropping off at the SLC airport.
- Proof of insurance with \$1.5 million for <u>each</u> vehicle under 16 passengers or \$5 million for <u>each</u> vehicle with 16 or more passengers. VIN numbers must be listed on the insurance form and Park City Municipal must be listed as the Interested Party. Insurance cards will not be accepted.
- Proof of current registration for each vehicle must be presented and information must match the vehicle.
- A Utah Z or P class endorsement must be on your driver's license.
- Your company name and phone number must be on the outside of the front doors or the back side windows. The letters should be not less than 5/16" wide and more than 2 1/4" high.

The following instructions are included to assist in filling out the for hire vehicle application. If you have further questions please call (435) 615-5225.

- 1. Enter the business sales tax number here.
- 2. Enter the name of insurance carrier.
- 3. When the business' name was registered with the State Of Utah (www.commerce.utah.gov), a DBA number was assigned.
- 4. When registering the business a Federal ID Number (FIN or EIN) was assigned
- 5. If your business is registered using a SSN instead of a Federal ID number enter the SSN here.

- 6. Enter the name of the business as well as any d.b.a. name along with the physical address of the business office.
- 7. Enter the mailing address, even if it is the same as the business' physical address. Enter the business telephone number and a website and/or email address if there is one.
- 8. Enter the NAICS Code that matches the type of business applying for.
- 9. Select if it is a home occupation or not and enter the business owners drivers license number.
- 10. Enter the name, address, phone number & birth date of the Manager.
- 11. Enter the name, address, phone number & birth date of the Responsible Party.
- 12. Enter the name, address, phone number & birth date of the Owner.
- 13. Read and understand this paragraph before it is signed. Enter the signer's position, their signature and the date of signature.

FEES – \$84.83 per vehicle and \$71.83 per license.

At time of licensing the following items must be presented for each vehicle:

- 1. An inspection: Airport or Park City (for Park City inspection sheet contact licensing (435) 615-5225)
- 2. Proof of Insurance: \$1.5 million and each VIN number that is being licensed must be listed
- 3. Proof of Registration
- 4. "Z" or "P" endorsed Utah State drivers license

After verifying the above items a sticker will be issued by Licensing and a physical inspection done to verify information and compliance of regulations.

Please make sure that the application has been signed, dated, has your company Federal ID number and a phone number for a Local Responsible Party who can answer questions that may come up.
