Foundation: The foundation, visible in the 2008 photographs, is concrete.

Walls: The exterior walls were clad in Tyvek, awaiting the final siding, as of the 2008 photographs.

Roof: The roof had not received its final materials as of the 2008 photographs.

Windows/Doors: The windows are one-over-one, double-hung sash with simple casing. The entry door had not been installed as of the 2008 photographs.

Design (The combination of physical elements that create the form, plan, space, structure, and style. Describe additions and/or alterations from the original design, including dates--known or estimated--when alterations were made): This was initially a simple frame single-story pyramid or foursquare house with an inset corner porch under the main roof line. The c.1940 tax photo showed a three-sided bay window with a hipped roof on the façade but it was removed as of the 1978 site form survey. By the time of the 1995 photograph a fixed pane window was installed in the place of the bay. The bay was restored by the 2006 photograph. In 2008 construction began to lift the house and put a basement garage and window under it in addition to adding two roof dormers; gabled in front and hipped on the side. It is not clear if the siding that will be used is the original siding or new siding milled to match the old or a combination of both.

Setting (The physical environment--natural or manmade--of a historic site. Describe the setting and how it has changed over time.): The house is located on a lot that slopes upward from the finished road bed. Like most of the historic neighborhoods in Park City, the overall setting is a compact streetscape with narrow side yards and other homes of similar scale within close proximity.

Workmanship (The physical evidence of the crafts of a particular culture or people during a given period in history. Describe the distinctive elements.): Much of the physical evidence from the period that defines the typical Park City mining era home has been altered and, therefore, lost.

Feeling (Describe the property's historic character.): The physical elements of the site, in combination, do not effectively convey a sense of life in a western mining town of the late nineteenth and early twentieth centuries.

Association (Describe the link between the important historic era or person and the property.): The Pyramid or foursquare house was a common house type built in Park City during the mining era; however, the extent of the alterations to the main building diminishes its association with the past.

The extent and cumulative effect of alterations to the site render it ineligible for listing in the National Register of Historic Places.

The site must represent an important part of the history or architecture of the community. A site need only be significant under one of the three areas listed below:

Park City was the center of one of the top three metal mining districts in the state during Utah's mining boom period of the late nineteenth and early twentieth centuries, and it is one of only two major metal mining communities that have survived to the present. Park City's houses are the largest and best-preserved group of residential buildings in a metal mining town in Utah. As such, they provide the most complete documentation of the residential character of mining towns of that period, including their settlement patterns, building materials, construction techniques, and socio-economic make-up. The residences also represent the state's largest collection of nineteenth and early twentieth century frame houses. They contribute to our understanding of a significant aspect of Park City's economic growth and architectural development as a mining community.²

One-story frame home with a hip-style roof. The porch to the south still contains decorative woodwork; however, the front portion of the building has been significantly altered (in about 1968). Windows have been replaced with aluminum frames; and a bay window on the north section has been totally removed, having been replaced with a fireplace.

According to the Sanborn Maps, the structure is shown as completely different in 1900.

A building contributory in style, and in all probability built by Park City notary and mining man, Thomas Cupit.

Cupit was listed as the "property" owner in 1879, and abstracts records show a lien on the property in 1902 that included the "building."

Thomas Cupit in 1892-93 served as a Park City Alderman. In October, 1898, after the fire of June 19, he erected a two story structure on Main Street that seemed as a business establishment and I.O.O.F. Hall. Cupit was listed in the 1903-04 Utah Gazetteer as "notary public and mining."
