

1. When does registration open for 2026 Summer Day Camp?

[Camp registration](#) (and all other summer program registration) opens to the general public online at 7:00am on Wednesday April 1, 2026.

Early registration is available for the prior year (2025) Full Summer Campers and those that reside or work in the 84060 zip code beginning at **7am on Monday, March 16th**.

To qualify for early registration:

- Provide proof of residency or current employment in 84060 boundaries to matt.principe@parkcity.gov or submitted in person to the PC MARC front desk (Attn: Matt Principe) no later than 5pm on Friday March 13th, 2026.
- Proof of residency or employment in 84060 must be submitted **every** year to qualify for early registration. Those living or working in 84098 do not qualify for early registration.
- 2025 Full Summer Campers do not need to provide proof of residency or employment in 84060.
- Please be advised that camp space will be limited this summer to ensure a high-quality experience for all participants. We look forward to welcoming more campers than ever before at our new facility the MINE at Park City, in Summer of 2027.

2. What are the ages for Summer Day Camp?

Camp is open to children ages 6-12 years. Exceptions may be made for 5-year-olds ON A TRIAL BASIS only if they meet the following criteria: *1) have attended a full day kindergarten or pre-school program, 2) have an older sibling registered as a full-summer camper in the program, AND 3) are registering as a full-summer camper.* Camp days are long, busy days and even our 6-year-olds sometimes have a hard time keeping up. If camp staff feel that a child is too young for the program, we reserve the right to notify the parents and cancel the child's registration with a refund for days not attended. Please note: exceptions must be requested PRIOR to registration by contacting Matt Principe: matt.principe@parkcity.gov or 435-615-5412.

3. Where will camp be located this year?

Camp will operate out of City Park this year, with Miner's Hospital serving as our administrative home base/indoor area. Camp will focus heavily on off-site programming this year, by utilizing city vans with certified drivers, public transit, and Field Trips served by chartered transport.

4. Are scholarships available for 2026 Summer Day Camp?

Yes. Applications for Park City Recreation's Sliding Fee Scale program are available online and in person at the MARC front desk. Applications must be received and approved prior to registration opening for the best chance at enrollment – Please allow 2 weeks for processing. 5. Do I need to register for add-on programs on March 16th as well? (Skate, tennis, pickleball, swim, & golf)

Add-on programs are available for registration throughout the summer, but open as part of general registration on April 1st (not priority Day Camp registration). Many of these programs will sell out, so it is

best to register early, but as long as space is available, you and your child can decide what is best for them as the summer progresses.

6. Is the entire balance of camp registration due at time of registration?

A payment plan option is available during the checkout process only for full-summer campers, though paying in full is preferred as these are processed manually. Daily Camper registrations do not qualify for a payment plan – These will need to be paid in full at the time of registration.

If you need to make alternative payment arrangements, please contact Matt Principe *prior* to registration opening to discuss options.

7. My child is on the waitlist – how does that work?

When camp begins on June 8th our staff will monitor attendance on a daily basis. If space becomes available they will make phone calls according to the waitlist to fill spots. As families begin to solidify their plans leading up to the summer, changes are made and often spaces do open up.

Once camp begins, the best course of action is to call the staff directly at 435-615-5440 during office hours (8am – 10am & 4-5pm) to inquire about space availability.

8. What are camp hours?

Park City Summer Day Camp is open from 8:15am – 5:30pm Monday through Friday, June 8th – August 14th, 2026 (Dates may change depending on the Park City School District Calendar). Please note that drop-off is between 8:15-9:45am and pick-up is between 4:00-5:30pm. *Organized activities take place between 10:00am – 4pm. 8:00-9:45am and 4:00-5:30pm is supervised free time.*

Parents may drop-off and pick-up outside of the designated times with proper communication with Summer Day Camp Directors.

9. How do field trips work?

Field trips will be held both in-house and offsite. Campers will be required to participate in the in-house or local fieldtrips – Parents who do not pay for these in advance will be charged automatically to the card on file. These field-trips will be a smaller cost as we will have presenters join us at City Park or take the City Bus to local venues.

Offsite fieldtrips are limited in space as we utilize a private school bus company. Smaller children who require a car seat will be given priority to ride in the recreation van. Field-trip registrations will open once venues are confirmed – This will be communicated to parents that have registered their kids for Summer Day Camp. Those who do not want their child to attend an offsite field trip now have an option to stay on-site at City Park for the day. Likewise, campers who do not secure a spot on a field-trip will stay on-site at City Park. Offsite field-trips incur a higher cost to cover transportation and entry fees. We do our best to keep these trips affordable while still providing fun alternatives for the kids. Registration for field trips may be done in advance online or at camp.
