COMBINED AMENDED GRANT OF EASEMENTS

WHEREAS, SWEENEY LAND COMPANY, a partnership organized and existing under the laws of the State of Utah for itself and as successor-in-interest to Tramway Properties, a general partnership organized and then existing under the laws of the State of Utah; EDMUND J. BEAULIEU, an individual, and CLYDE CARLIG, an individual, all as successors-in-interest to Tramway Properties; BROTHERS HI, L.L.C., a limited liability corporation organized and existing under the laws of the State of Utah, as successor-in-interest in part to Sweeney Land Company and in part to Park City Depot Corporation, a corporation organized and then existing under the laws of the State of Utah; THE CALEDONIAN CONDOMINIUM ASSOCIATION, INC., a non-profit corporation organized under the laws of the State of Utah, as successor-ininterest in part to Sweeney Land Company and in part to Park City Depot Corporation; all and where their interests appear of record (collectively hereinafter "Grantors"), and GREATER PARK CITY COMPANY, a corporation organized under the laws of the State of Utah (hereinafter "Grantee") desire to amend and to restate in full as amended that certain First Amended Grant of Easement, heretofore executed on the 14th day of August, 1996, and recorded as Entry No. 00460579, in Book No. 00985, Page Nos. 00753-00759, of the Official Records of Summit County, Utah;

WHEREAS, Grantee owns and operates a ski lift known as the "Town Lift" situated in Summit County, Utah, which connects the base facilities in Park City, Utah, with the Park City Mountain Resort operated by Grantee; and

WHEREAS, Grantee may in the future, construct (subject to obtaining appropriate approvals from Park City Municipal Corporation) a lift that runs from the existing mid-station of the Town Lift upward to a point on the Payday Run (the "Upper Lift");

NOW, THEREFORE, for Ten Dollars and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantors hereby convey and warrant to Grantee and its successors and assigns the following easements:

Base Station and Mid-Station. A non-exclusive easement granting Grantee the exclusive right to construct, maintain, operate, use, repair, replace, and relocate base stations and a mid-station, and related facilities and equipment, for the Town Lift and the Upper Lift (each ski chair lift of quadruple or triple, detachable or fix-grip type, gondola, or other comparable equipment as Grantee may determine), on, over, under, across, and through the following tracts of land situated in Park City, Summit County, State of Utah:

As described in Exhibit "A" and drawn on Exhibit "D" hereto.

2. Town Lift. A non-exclusive easement granting Grantee the exclusive right to construct, maintain, operate, use, repair, replace, and relocate the Town Lift, the Upper Lift and related facilities and equipment (a ski chair lift of quadruple or triple, detachable or fix-grip type, gondola, or other comparable equipment as Grantee may determine), on, over, under, across, and through the following tract of land situated in Park City, Summit County, State of Utah:

3. Ski Trails. A non-exclusive easement granting Grantee the exclusive right to construct, maintain, operate, use, repair, replace, and relocate such ski runs and trails, snow-making equipment, signs, skier controls and mazes, safety fences, and associated facilities and equipment as Grantee may determine, on, over, under, across, and through the following tract of land situated in Park City, Summit County, State of Utah:

As described in Exhibit "C" hereto and drawn on Exhibit "D" hereto

The easements granted in the foregoing Sections 1, 2, and 3 are not intended and shall not be construed to preclude the owners of the lands subject to such easements from occupying and using such lands for any and all purposes not inconsistent with and which do no interfere with the rights granted Grantee herein.

The easements granted herein shall continue for a term of 70 years from the date hereof, and shall be automatically renewed every five years thereafter for so long as Grantee operates the Town Lift in accordance with the Town Lift Agreement (as defined below) in consecutive years, snow and weather conditions and other operating conditions beyond Grantee's control permitting.

The easements granted herein are for the purpose of facilitating the construction, maintenance, operation, use, repair, and relocation of the Town Lift, the base station for such lift, the mid-station for such lift, the ski trails served by such lift, and related facilities and equipment. The Town Lift interconnects the base facilities for such lift with the Park City Mountain Resort operated by Grantee. The easements granted herein are for the benefit of and are intended to run with title to the lands more particularly described in Exhibit "E" hereto.

The easements granted in Paragraph 3 above, are granted subject to the right of an individual Grantor to modify and relocate ski trails and associated facilities and equipment situated on lands owned by such Grantor; provided, however, that such relocation shall be made by Grantor at the expense of such Grantor, and that the relocated ski trails and associated facilities and equipment shall be substantially equivalent to those relocated and shall work in an integrated and harmonious fashion with adjoining ski trails and associated facilities and equipment of Grantee; and provided, further, that Grantee's prior written approval of such relocation shall be required, not to be unreasonably withheld.

Reserving to each individual Grantor: (i) the right to use Grantee's ski trails situated on lands owned by such Grantor for purposes of skiing to and from such lands; (ii) the right to construct ski trails on such Grantor's lands for the purpose of providing access to and from Grantee's ski trails; provided, however, that Grantee's prior written approval of ski trails constructed by Grantor shall be required, not to be unreasonably withheld; (iii) the right of such Grantor to use the easements for underground utilities; (iv) the right of such Grantor to landscape within the easements (but not so as to interfere with the use of the easements); and (v) the right of such Grantor to use the lands subject to such easement for all other purposes not inconsistent with or interfering with the rights granted Grantee in this Agreement.

This Combined Amended Grant of Easements may be executed in any number of counterparts. Each such counterpart hereof shall be deemed to be an original instrument, but all such counterparts together shall constitute but one agreement. This Combined Amended Grant of Easements shall be effective as between an individual Grantor and Grantee when each has executed

a counterpart hereof. This Combined Amended Grant of Easements shall be binding upon each of the parties hereto, and their respective heirs, personal representatives, successors, and assigns.

It is understood and agreed by each of the parties hereto that should any property description used herein be found to be incorrect or otherwise misstated, all parties to this Combined Amended Grant of Easements shall execute and deliver such further amendments as are reasonable and necessary under the circumstances to correct such description(s) and to otherwise fully effectuate the intent of the parties.

This Agreement amends, restates in full as amended, and supersedes in its entirety the First Amended Grant of Easement described in the first paragraph hereof. Without limiting the generality of the foregoing sentence, the easements granted herein supersede and replace the easements established by the following documents of record, and Grantee relinquishes the easements established by the following documents of record:

- First Amended Grant of Easement executed by Quitting Time Ltd., to Greater Park City Company which replaces and substitutes for the prior easement recorded with the Summit County Recorder at Entry No. 275505, Book 441, at Page Nos. 609-613. Said Amended Grant of Easement recorded August 14, 1996, as Entry No. 460579, in Book 985, at Page 753, at the Summit County Recorder's Office.
- Grant of Easement between Sweeney Land Company and Greater Park City Company, a Utah corporation. Said Grant recorded August 20, 1987, as Entry No. 275504, in Book 441, at Page 599, Summit County Recorder's Office.
- Grant of Easement between Sweeney Land Company and Greater Park City Company, a Utah corporation. Said Grant recorded August 20, 1987, as Entry No. 275506, in Book 441, at Page 614, Summit County Recorder's Office.
- Grant of Easement between Sweeney Land Company and Greater Park City Company, a Utah corporation. Said Grant recorded March 17, 1989, as Entry No. 306089, in Book 516, at Page 139, Summit County Recorder's Office.
- Grant of Easement between Sweeney Land Company and Greater Park City Company, a Utah corporation. Said Grant recorded March 17, 1989, as Entry No. 306090 in Book 516, at Page 151, Summit County Recorder's Office.

Further understandings and agreements with respect to the Town Lift and related matters between Grantors (or their predecessors), Grantee, and others are set forth in the Agreement dated November 30, 1981, as amended on October 5, 1982, August 14, 1984, February 25, 1997, and , 1999, and as the same may be further amended from time to time (the FES "Town Lift Agreement"). Reference is made to the Town Lift Agreement for the particulars thereof. Nothing herein is intended to limit the rights or obligations of Grantors or Grantee under the Town Lift Agreement.


