NARRATIVE DESCRIPTION OF PROPERTY

835 Woodside is a variation on a T/L cottage that has undergone extensive changes. The T/L cottage, also known as a cross-wing, is one of the main three house types built during the historic Park City mining era. This house has been raised and the site excavated to construct a lower level and garage addition. An addition was also constructed to the south off the stem wing. The cross gable roof is sheathed with standing seam metal and has a brick chimney. The brick of the chimney is newer and has been reconstructed. The walls are clad with drop-novelty wood siding, and the concrete foundation is showing at grade. Though the windows are mostly obscured in the c. 1940 tax photo, they have most likely been modified. The current windows are all one-over-one double hung sash windows, with a pair in the front gable end, a pair in the lower level underneath the porch, a single window in the porch area left of the door and another single in the south

addition. The door is a wood frame and panel door with an upper oval light. The porch is covered by a shed roof extension of the main roof extending from the primary façade. The porch roof is supported by lathe turned wood posts with a railing between. The porch is entered from the side via a stair that leads up from the sidewalk. A stone retaining wall sits in between the stair and the driveway. Although the overall forma remains legible, the cumulative formal and material changes have diminished its historic value.

Narrative Statement of Significance:

This house was built before the drawing of the 1889 Sanborn Insurance map, which makes it difficult to determine when its construction occurred. It was built under the ownership of either the Park City Townsite Corporation or Laura fay, the first individual to own the property. Nothing is known of Laura Fay, but she sold the house in 1905 to Mary Farrell.

Mary owned the house with her husband, A.J., but no other information could be found on them. They sold the house to J.M. Faddies in 1907. The only information that could be found on a J.M. Faddies, was that he lived in Coalville, and it appears that he rented out the house, as it was occupied by William and Annie Moulton during the 1910 census. William worked as a teamster in Park City. The house was sold in 1913 to Mrs. James Toly.

No information could be found on Mrs. James Toly or her husband, and it is assumed that they did not live in Park City and either rented the house out or left it vacant. The next owner was John Jackson. Park City newspapers reference a John Jackson, but it is unknown if this is the same person. The house continued to be rented out during the 1920 census, this time being occupied by Wallace Davis, his wife Lila and their two daughters. Wallace was a miner in Park City. The house was sold in 1921 to Margaret Matheson.

Little information could be found on Margaret Matheson, but she appears on the 1930 census, still living in Park City, but in a different house. She sold the house to Arthur Lefler in 1924. Arthur Lefler lived in the property during the 1930 census with his wife Mary, and their three children. Arthur was a shift boss for a mine. They owned the house until 1936, when it was purchased by Wilford Binggelli.

Wilford Binggelli lived in Park City with his wife Retta and their daughter both before and after his ownership of this house. He worked as a laborer for a mine, and also as a carpenter. They sold the house in 1937 to the State Bank in Park City, which owned it until it was bought by Joseph Turner in1938. No information could be found on him, except that he transferred the property in 1939 to his daughter Vivian Wright.

Vivian Wright lived in the house with her husband Leo William and their three sons. Leo worked as a hoisting engineer for a mining company. They had previously lived in Charleston, but had recently moved to Park City, likely in 1939. They owned the house until 1948. The house has had several owners since the historic period, and is currently owned by Gary and Sharon Bush.
